### *What is the GARI project?*

The Global Accessibility Reporting Initiative (GARI) is a new project aimed at providing information about the accessibility features of various mobile phones for consumers with disabilities or special needs. The GARI project is also empowering consumers to search for phones that have the features that they are looking for to meet their requirements.

The project itself comprises a multilanguage website available at [www.mobileaccessibility.info](http://www.mobileaccessibility.info) that has been developed to provide a central information source to learn about accessibility in mobile devices, as well as a detailed database of mobile phones that allows consumers to search, compare and view models that may be of assistance to them.

### *Why is the industry launching the GARI project?*

The Mobile Manufacturers Forum (MMF) and its member companies Alcatel Mobile Phones (TCT Mobile), Apple, LG, Motorola Mobility, Nokia, Samsung and Sony Ericsson share the objective of consumer and advocacy groups as well as the government to eliminate the barriers that prevent access to the social, economic and safety benefits of mobile telecommunications.

Other mobile phone manufacturers are welcome to join the project by discussing it with the MMF.

### *How will the GARI project help consumers?*

The project comprises three elements:

- A universal 'accessibility features template' that is being used by manufacturers worldwide to provide information on some 100 features of phones that may assist different users;
- A dedicated accessibility website – [www.mobileaccessibility.info](http://www.mobileaccessibility.info) – that provides general information for users that complements and explains various features of phones; and
- A unique Internet tool to search and compare mobile phone models in order to quickly find out which models may provide the best match for a consumers particular needs.

These three elements will allow consumers with accessibility needs or those helping them to find the mobile phone best suiting their requirements.

### *Which models of phone can I find on the GARI website?*

The project is being progressively introduced for mobile phones from MMF member companies. Available models can be viewed at [www.mobileaccessibility.info](http://www.mobileaccessibility.info)

### *Can stakeholders link to the site or promote awareness of it?*

Yes, the mobile industry would like to work with all stakeholders to promote awareness of the program and to work together to eliminate the barriers that prevent access and the benefits of mobile telecommunications. This attitude to involve concerned stakeholders is also supported by the Disability Intergroup as the oldest as well as largest group in the European Parliament. The Disability Intergroup via the European Disability Forum supports the GARI project by ensuring that the accessibility features template, dedicated website and Internet comparing tool suit the needs of persons with disabilities in order to provide them with accurate and useful information. There are many ways to promote awareness of the GARI website from including links on stakeholder websites, to inclusion of materials in newsletters and other communication materials.

We welcome further feedback and ideas to improve the project as it is implemented globally. Moreover, the GARI templates will be formally reviewed every year to ensure that they reflect the latest requirements, requests and technology. We are looking at ways to formally include relevant groups into the review process on a global basis.
